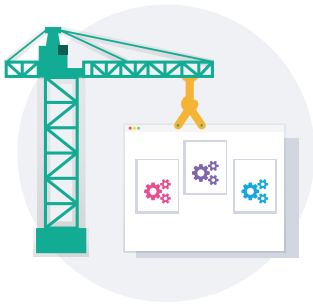

## COMPLY WITH REGULATIONS AND STANDARDS

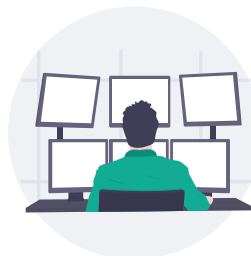
Regardless of your industry sector, your organisation is under increasing pressure to demonstrate compliance with the standards, regulations and legislation that your customers, industry and government require.
